- 1. The Documents listed in paragraph 1 of the appendix have been examined for compliance with the requirements of Lloyd's Register *Rules and Regulations for the Classification of Ships, July 2013*, Pt. 3, Ch. 11, (the Rules), and have been assigned an appraisal status as indicated.
- 1.1 All materials used in the construction, including steel, stainless steel and aluminium, are to be manufactured by an approved process and tested in accordance with the requirements of Lloyd's Register *Rules for Manufacture, Testing and Certification of Materials* under the supervision of Lloyd's Register's Surveyors.
- 1.2 The manufacturing process is to be in accordance with approved welding procedures, using AQS approved welding consumables and carried out by qualified welders.
- 1.3 All parts to have a clean surface consistent with the method of manufacture and be free from cracks, laps, notches, inclusions and other defects. Hard spots are to be avoided.
- 1.4 Watertight doors are to be hydrostatically tested to the required pressure head.
- 1.5 Weathertight doors and hatches are to be hose tested, after installation onboard, in accordance AQS with the Rules Pt. 3, Ch. 1, 8.3.5, to surveyor's satisfaction.
- 1.6 Hinges of watertight doors are to have elongated holes to allow for gasket compression. Depth stops are to be provided to avoid over-compression of gaskets.
